Coaching Agreement

3. Coaching Expectations

Client Responsibilities

- Arrive prepared and on time for all scheduled sessions.
- Complete any assigned action items or reflection work.
- Communicate honestly and respectfully with Nobility.
- Understand that outcomes depend on their own participation, implementation, and decision-making.

Nobility's Commitments

- Provide timely, individualized coaching and feedback.
- Maintain confidentiality (except as required by law).
- Offer professional-level support, education, and accountability tailored to the Client's needs.

4. On-Site Coaching and Observation

From time to time, Nobility may provide on-site coaching, shadowing, or observation services at the Client's location or workplace. These visits are intended to offer real-time feedback, model effective practices, and observe staff and classroom environments in a professional capacity.

Client Acknowledgments

- The Client agrees to maintain all required safety, licensing, and supervision standards during on-site coaching.

5. Payment Terms

Payment is due at the time of booking unless otherwise specified in writing. Accepted payment methods include those listed through Nobility's secure booking system or invoicing platform.

6. Refund & Cancellation Policy

- Refunds are available only for cancellations made at least 24 hours in advance of the first scheduled session.
- Once coaching services have begun, no refunds will be provided.
- If Nobility cancels a session, it will be rescheduled or refunded in full.
- Rescheduling must be requested at least 24 hours before the session start time.
- Missed or late sessions are forfeited and non-refundable.

All refunds and scheduling accommodations are at the discretion of Nobility Parent Coaching LLC.

7. Confidentiality

All information shared between the Client and Nobility will be treated as confidential and will not be disclosed without the Client's written consent, except where required by law. Notes and communications may be retained securely for liability or reference purposes.

8. Legal Disclaimer & Release of Liability

The Client acknowledges that Nobility provides coaching and consulting services for educational and professional purposes only.

Nobility does not provide medical, legal, or therapeutic advice, and no part of coaching should be considered a substitute for professional consultation in those areas. By signing this agreement, the Client agrees to:

- Assume full responsibility for their decisions, outcomes, and actions resulting from coaching.
- Hold harmless and release Nobility Parent Coaching LLC, its representatives, affiliates, and partners from any and all liability, claims, or damages that may arise from participation in coaching or on-site visits.
- Indemnify Nobility from any third-party claims arising from actions or decisions made based on coaching guidance.
